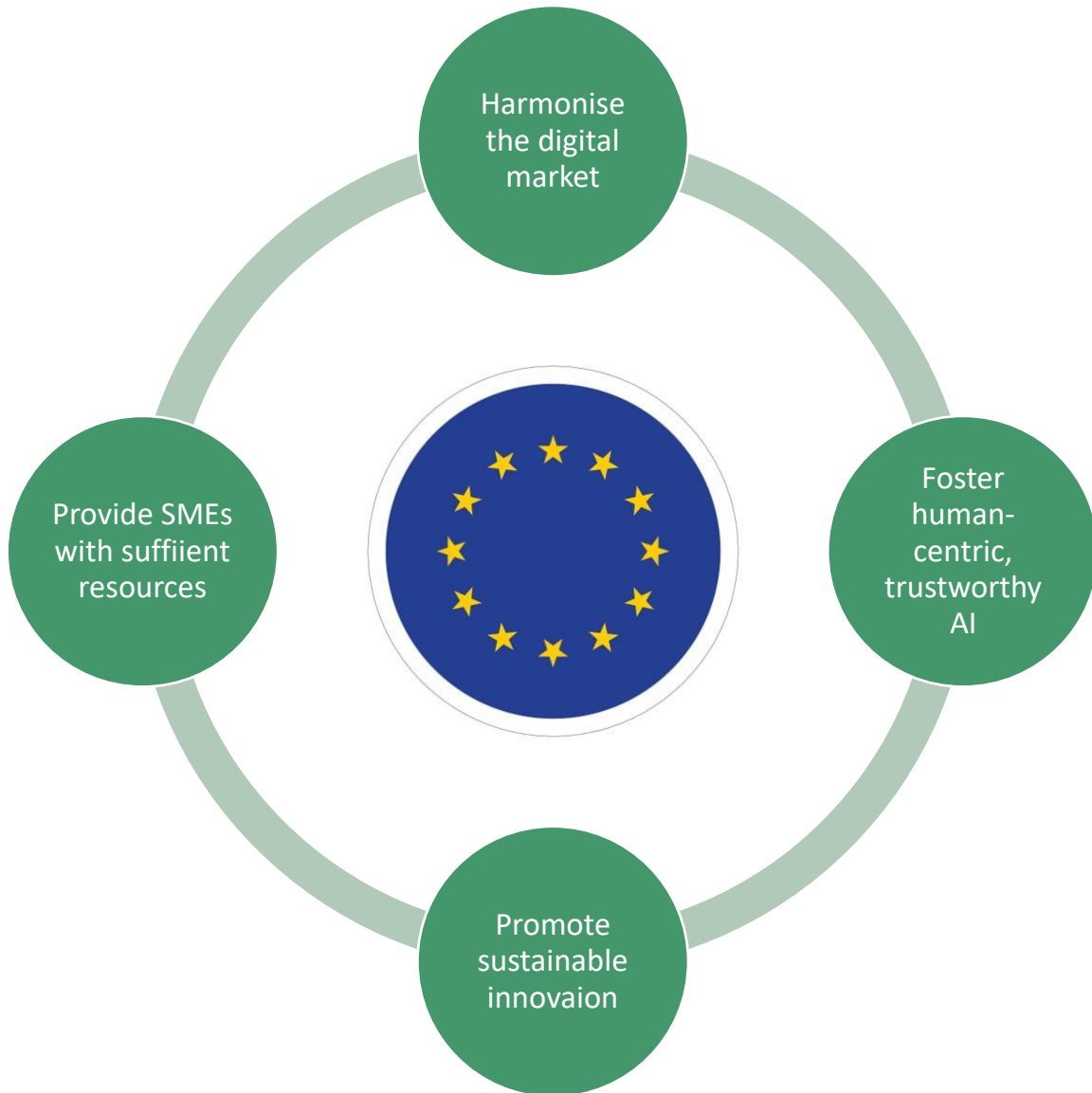

Figure 2: Steps that SMEs and start-ups can take to verify their eligibility for AI Regulatory Sandboxes

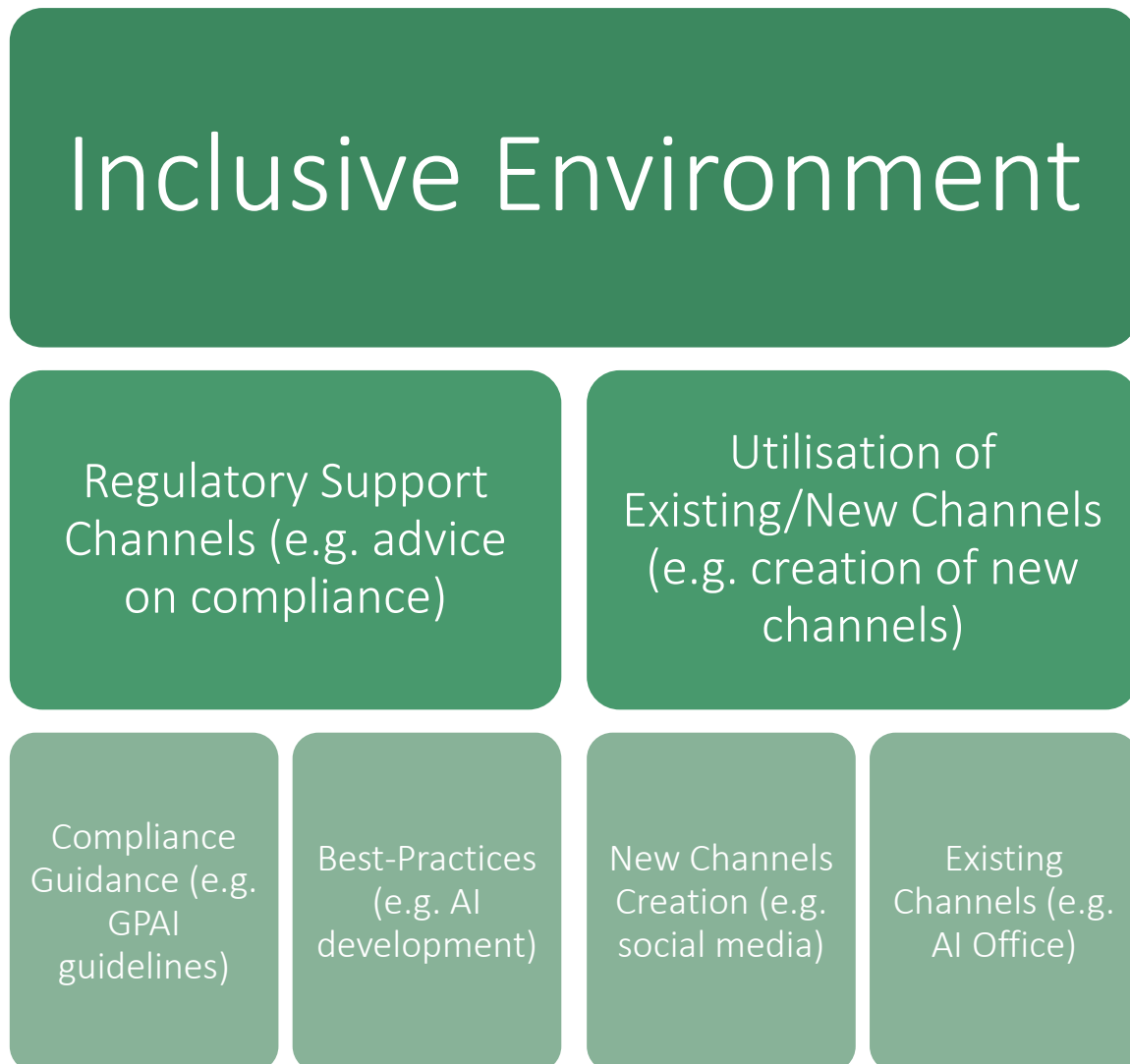


Establishing Dedicated Channels: A Closer Look

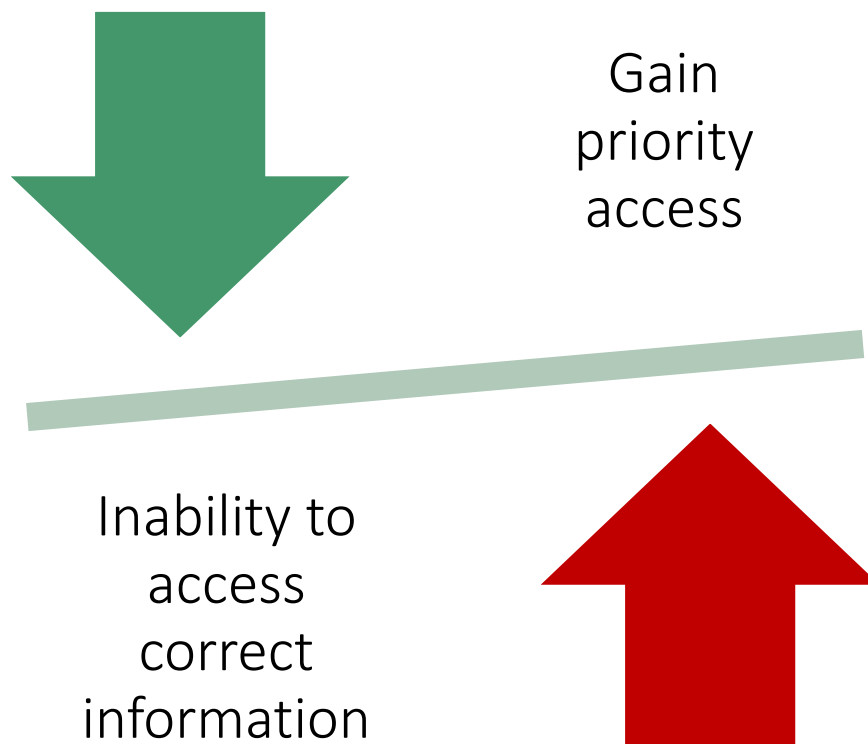
This framework goes beyond compliance—it fosters innovation by providing a clear path for smaller businesses to develop cutting-edge AI systems that meet high safety and ethical standards.

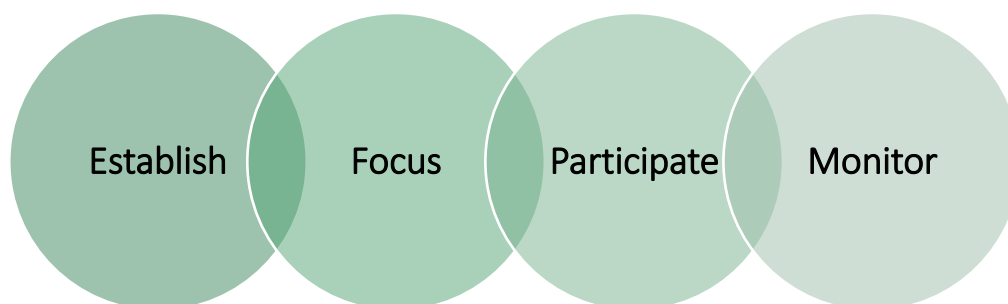
Participate in Regulatory Training Programs
